NORTHERN ILLINOIS SYNOD EVANGELICAL LUTHERAN CHURCH IN AMERICA THIRTY-FIFTH ANNUAL ASSEMBLY JUNE 16-17, 2023

PLENARY SESSION I – Friday, June 16th

Opening of the Assembly

After a note of welcome, Bishop Stacie Fidlar and Rev. Dr. Charlene Rachuy Cox led us in an opening liturgy followed by the Hymn, "Canticle of the Turning" with a procession. Order for the Opening of the Assembly with land acknowledgement was presented by Bishop Fidlar. Bishop Fidlar introduced the purpose of the event followed by introductions of people seated on the platform and guests in the audience. A video greeting was presented by Augustana College President Dr. Andrea Talentino.

Credentials Report

Bishop Fidlar called on Rev. Jennifer Ohman-Rodriguez, Chairperson of the Credentials Committee, to give the credentials report as follows:

213 Lay Members (68%) 102 Rostered Members (32%) Total of 315 Voting Members

A quorum was established.

Bishop Fidlar led us through the procedures for speaking at the microphones and voting followed by a test vote on Slido.

Approval of Agenda

Bishop Fidlar called on Secretary Cantrell to present the agenda.

Bishop Fidlar instructed the assembly that items could be pulled from the agenda and the consent agenda at this time.

ACTION SA-23-06-01 Secretary Cantrell made a motion on behalf of the synod council that the agenda for the Synod Assembly prepared by the synod council and found in the Bulletin of Reports on the synod website, be adopted, as the agenda for the 2023 Northern Illinois Synod Assembly. The motion was approved.

Approval of Consent Agenda

Bishop Fidlar called on Secretary Cantrell to present the consent agenda.

ACTION SA-23-06-02 Secretary Cantrell on behalf of the Synod Council, moved that the Consent Agenda which includes the Rules of the Assembly, Committee Appointments, and the 2022 Synod Assembly Minutes found in the Bulletin of Reports be adopted as the Consent Agenda of the 2023 Northern Illinois Synod Assembly." The consent agenda was approved.

Keynote Speaker

Rev. Dr. Charlene Rachuy – Cox shared a message based on Isaiah 43 focusing on, "but now...I love you and you are mine." She also referred to the poem by Mary Oliver, "A Summer's Day."

Bishop Fidlar called on Ms. Jennifer Prinz to give a report on Portico.

Bishop's Report

Bishop Fidlar called on synod Vice President Ms. Minnette Willard to take the chair so she could give us her report with these highlights:

- Faithful Innovations Lab and Vital Congregational Work DEM Rev. Josh Ebener
- Introduction of Rev. Jose Pilar, former president of the Lutheran Church of Guatemala. He will oversee a joint Latino ministry in the Quad Cities with the partnership of the Northern Illinois Synod and the Southeastern Iowa Synod. Rev. Pilar greeted the assembly.
 - o Bishop asked how we can support Rev. Pilar in his work with these suggestions:
 - Mission Team one time
 - Mission Partners reoccurring gift
 - Mission Dreamers gift to the Innovation Team Fund

The assembly offered its thanks for the Bishop's report with applause. Vice President Willard returned the chair to Bishop Fidlar.

Synod Treasurer's Report

Bishop Fidlar called on Treasurer Ms. Tammie Farley to give her report. The assembly offered its thanks to Treasurer Farley with applause.

Presentation of the Proposed Budget for 2024

Bishop Fidlar invited Treasurer Farley to introduce the proposed NIS Budget for 2024 which will be voted on in Plenary Session 2.

Resolution R1

Bishop Fidlar called acting chair of the Resolution's committee, Rev. Andrew Kayes, to read the "resolved" sections of Resolution 1 – Growing in Faith: The diakonia Program.

Be it resolved that this Assembly of the Northern Illinois Synod of the Evangelical Lutheran Church in America:

- 1. Affirm and celebrate that **Growing in Faith: The diakonia**TM **Program** is in partnership with NIS for adult faith formation and as a foundational resource for Synodically Authorized Ministers.
- 2. With the assistance of the Synod, fund special projects for the ongoing ministry of **diakonia**TM (e.g., publicity, national website administrator, retreats, scholarships), with the possibly having an annual **diakonia**TM Sunday offering.
- 3. Encourage rostered leaders to invite parishioners to take part in this program of faith formation."

Bishop Fidlar instructed the assembly that we only discuss the "Resolved" sections of the resolution.

PLENARY SESSION 2– Saturday, June 17th

Gathering Hymn and Opening Ritual of Longing and Hope

Bishop Fidlar led the assembly in a time of worship, commemoration of the Emmanuel Nine and an acknowledgement of Juneteenth.

Credentials Report

Bishop Fidlar called on Rev. Jennifer Ohman-Rodriguez for the credentials report.

225 Lay Members (66%) 117 Rostered Members (34%) Total of 342 Voting Members

A quorum has been established.

Vice President Report

Bishop Fidlar called Vice President Ms. Minette Willard to share her report with the assembly. The assembly received her report and showed appreciation with applause.

Mission Investment Fund Video

Resolution R2

Bishop Fidlar called acting chair of the Resolution's committee, Rev. Andrew Kayes, to read the "resolved" sections of Resolution R2 – Memorialize Churchwide to Update the Social Statement on Abortion.

Be it resolved that the Northern Illinois Synod of the Evangelical Lutheran Church in America requests that Churchwide leaders revise, update, or create a new Social Statement on Abortion; and

Be it further resolved, this process should include the partnership of women clergy, women deacons, and lay women of our Synods and congregations.

Discussion included:

Rev. Julane Neese of United Lutheran, Rockford speaking in support of R2.

Mx. Samuel Carrington of 1st Lutheran, Galesburg asked how a woman is defined and will there be an emphasis on those who have uteruses or those who identify as women.

Bishop Fidlar described the process of what would happen once the document is submitted to churchwide and that they will seek the broadest group.

Ms. Kearsti-Rae Knowles of Trinity Lutheran, Mt. Morris said we need to be very intentional in the language we use when we present this to churchwide.

Bishop Fidlar asked Ms. Knowles if she was making a motion to write out a suggested amendment and bring it forward.

Mr. Brandon Graves of Salem, Sycamore presented an amendment as follows:

Be it resolved that the Northern Illinois Synod of the Evangelical Lutheran Church in America requests that Churchwide leaders memorializes the 2025 Churchwide Assembly to revise, update, or create a new Social Statement on Abortion; and

The motion was seconded.

Ms. Lori Dhabalt of St. Paul of Orion asked if there was a copy of the current social statement in the bulletin of reports. Bishop Fidlar directed the assembly to the NIS website.

The amendment passed.

Ms. Melanie Chavin of Salem Lutheran, Sycamore and Rev. Makayla Dahleen of St. Paul, Sterling proposed an amendment to include medical professionals.

Bishop Fidlar introduced the ELCA Youth Gathering Video and the Global Mission Committee Video as the amendments were being drafted.

Ms. Kearsti-Rae Knowles of Trinity Lutheran, Mt. Morris presented an amendment as follows:

Be it further resolved, this process should include the partnership of women clergy, women deacons, and lay women the partnership of clergy, deacons, and lay people who have uteruses or have had uteruses, and medical professionals including genetic counselors, perinatologist/maternal fetal medicine doctors, NICU providers, fetal palliative care providers, and OBGYNs of our Synods and congregations.

Motion is seconded.

Further discussion:

Rev. Don Knowles of Calvary, Moline and St. James Lutheran, Rock Island speaking against the amendment.

Ms. Gretchen Sprinkle of Salem, Sycamore speaks in support of the amendment.

Rev. Jacob Gawlik of St. John's, Sterling asked a clarification question.

Rev. Janet Hunt of 1st Lutheran, Dekalb speaking in support of the amendment.

Mx. Samuel Carrington of 1st Lutheran, Galesburg – speaking in favor of the amendment.

Ms. Lori Whalen of 1st Lutheran, Ohio made a correction to the grammar.

Mr. Brandon Graves of Salem, Sycamore made a motion to end debate.

Second was given.

The motion to end debate on the amendment was passed.

The amendment passed.

Further discussion:

Rev. Ron Larson of Trinity of Mt. Morris shared a personal story asking that voices of those whose lives were saved be considered in the conversation of revising the social statement [on abortion].

Rev. Janet Hunt of 1st Lutheran, Dekalb stated that the wheels of the Church move slowly. She encouraged us to follow the example of the North Conference as we work with each other.

Rev. Frank Langholf of Emmanuel, Rockford speaking in support of the resolution.

Rev. Sarah Wilson of St. Barnabas, Cary speaking in support of the resolution.

Ms. Christina King of 1st Lutheran, Galesburg called the question.

A motion of calling the question and ending debate was made and seconded.

Motion passed.

Bishop Fidlar led the assembly in prayer before the vote on R2.

The vote was done by Slido with the results as follows:

Yes-94% No-6%

ACTION SA-23-06-04 The motion to approve Resolution R2 as amended was passed.

Rev. Don Knowles of Calvary, Moline and St. James, Rock Island speaking against the budget but instead make an effort to increase benevolence.

Mr. Larry Mine of St. James, Forreston suggest all congregations to find ways to give more to LOMC.

Rev. Bree Truax of Immanuel, Rock Falls speaking in favor of the budget.

Bishop Fidlar led the assembly in prayer.
